## **How the Federal Government Shutdown Impacts REALTORS®**

A federal government shutdown can directly impact real estate transactions by delaying or suspending services like flood insurance, VA and USDA loan processing, HUD programs, and certain IRS functions. Brokers should prepare their agents by identifying transactions that could be affected, helping them set clear expectations with buyers and sellers, and staying updated through NAR's advocacy resources.
