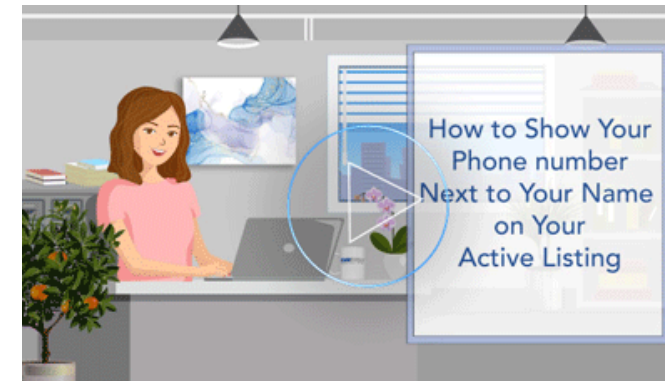
February is the National Association of REALTORS® (NAR) Diversity, Equity & Inclusion (DEI) month.

### NAR - Mandated MLS Rule Changes

At the November National Association of REALTORS® (NAR) meetings, the NAR Board of Directors passed a motion to revise several MLS rules and add new MLS rules.

Associations are mandated to adopt the following revised/new MLS Rules: MLS Sections 11.14, 11.15 and 11.16 were added, 7.5, 7.15, 12.10, 12.14, 12.16, and 12.19, were amended.
