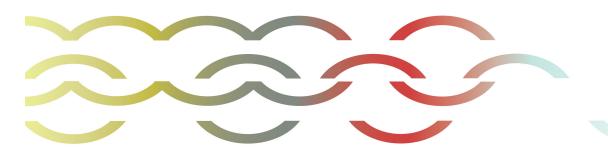

Directors' Review in Four Situations

- Review grievance committee decision, upon request
- Ratify disciplinary decision when no Request for Review
- Review hearing of disciplinary decision, upon request
- Review arbitration award, upon request



Ratification of Disciplinary Decision





Professional Standards – Case Ratification

- Type of Review
 - Paper review only: Findings of Fact and recommended discipline only
 - · No hearing
 - · Parties do not attend
 - Parties cannot challenge directors
- Directors must accept Findings of Fact as true no weighing of the merits
- Directors <u>must</u> adopt hearing panel decision and recommendation, UNLESS
 - · Deficient on its face
 - Discipline excessive or
 - Clear lack of due process

Professional Standards – Case Ratification

- Action of Directors
 - Ratify recommendation of hearing panel including recommended discipline
 - · Reduce the amount of discipline
 - If directors feel discipline should be increased, refer back to same hearing panel with recommended modifications
 - Directors may make modifications to increase discipline ONLY if panel refuses and such refusal would subject Association to liability
- Decision Final
 - · Upon being entered into minutes of Board of Directors
 - Consent agenda: i.e. "Directors affirm recommendation of hearing panel in case number XXXX."

What to Expect

- Staff will reach out to you before the board meeting.
- We will provide you party information and Certificate of Qualification Form.
- Plan to stay after the board meeting for 15 30 minutes.
- You'll receive the Panel's decision, Findings of Facts, and recommended discipline (if any).
- Presiding Officer may be the president or other designee.
- Presiding Officer is responsible for the final Action of Directors Form.
